Following inhalation

12.2 Persistence and degradability

AEROBIC: Glycerin, present at 100 mg/L, reached 63% of its theoretical BOD in 2 weeks using an activated sludge inoculum at 30 mg/L in the Japanese MITI test (1). Biodegradation rate constants of 0.258/day and 0.200/day in respirometric test systems employing activated sludge have also been reported, corresponding to 68% and 78% degradation, respectively (2).

12.3 Bioaccumulative potential

An estimated BCF of 3 was calculated in fish for glycerin (SRC), using a log K_{ow} of 1.76 (1) and a regression-derived equation (2). According to a classification scheme (3), this BCF suggests the potential for bioconcentration in aquatic organisms is low (SRC).

Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning.
